The Criteria

Criteria for the Iowa Mortgage Association's Winner's Circle & President's Club

1. Originators must originate loans in the State of Iowa, out of state production will be considered, but the home base or branch of the originator must be Iowa. Minimum loan origination eligibility is \$15 million or 100 units of residential loan volume in 2018 for Winner's Circle and \$20 million or 130 units of residential loan volume in 2018 for President's Club.
2. Application must be signed and verified by manager, president, accountant or CFO.
3. Entry must be received at IMA offices by e-mail by March 1, 2019. IMA will send confirmation via email to applicants that the application is received. If you don't receive a confirmation within 48 hours, please follow-up with Darcy Burnett at dburnett@iowabankers.com.
4. Must be an IMA member in good standing.
5. Only those registered to attend the Spring Conference by Friday, March 22 will be recognized at the event. All applications received by March 1 will be included in the recognition program, but you must register by March 22 to receive a certificate and be recognized.
